# PATH TO GLASS ACT SCHOOL RESIDENCY

## ABOUT THE RESIDENCIES

Canberra Glassworks, in conjunction with Capital Chemists, is offering one ACT student the opportunity to expand their artistic horizons with a two week artist residency at the Canberra Glassworks in Kingston.

The Path to Glass - ACT School Residency will be offered to one Year 11 or 12 student, currently enrolled at an ACT college or senior school. The successful applicant will receive a comprehensive introduction to one or two disciplines of glass practice of choice, which can include glass blowing, flameworking, engraving/coldworking, kiln forming and casting techniques. \*

The successful applicant will be supported and encouraged by staff, artists and the Canberra Glassworks Creative Fellow. An accomplished Canberra Glassworks artist/s will demonstrate glass processes and mentor the resident to ensure the safe handling of all materials and equipment.

\*Subject to teaching artist availability

## ELIGIBILITY

Australian citizens and permanent residents, who are currently enrolled students in Year 11 or 12 and attend an ACT college or senior school are eligible to apply.

## SELECTION

Your application will be reviewed on the following criteria:

- Ideas suitable for creation in glass
- Your skill and confidence in working in one or more artistic mediums
- Ability to communicate an idea or concept in writing or verbally
- Your interest and willingness to work in glass

In completing your application please submit the following:

- Completed application form
- 5 images of recent work. Please ensure that images are saved as jpegs and that no image is larger than 1.5MB
- Image details list (with completed credits)

## RESIDENCY ENTAILS

Two weeks of access to the Canberra Glassworks, including:

First week:

- Building induction.
- Workspace Access
- Artist mentoring across one or two glass working techniques.

Second week:

- Residency.
- \$500 allowance for further teaching artist mentorship and/or materials.
- Assistance from Education Manager on budgeting and booking of equipment and materials.
- Workspace Access
